## END USER LICENCE AGREEMENT FOR THE BIGGER PICTURE LIBRARY CC FOR THE USE OF ROYALTY FREE SINGLE IMAGES AND CD ROM HIGH RESOLUTION IMAGES.

This is a legal agreement between you, the User, and the company, **The Bigger Picture Library cc**, a reseller/agent that represent various local and international royalty free Image Providers in South Africa.

Read this agreement carefully before using any of the royalty free single or cd images purchased from us. **If you do decide to proceed, you are bound to the terms of the following agreement.**

### 1. Permitted uses

The user is permitted to:

- a. Use the images in the user's personal, professional, internal, editorial, and client projects including printed materials, advertisements, packaging, presentations, video, on-line or multimedia projects.
- b. Use the images in a resale product of any quantity.
- c. Use the images in a for-sale product of any quantity, providing the finished product(s) is designed for viewing purposes only and is not designed or intended for re-use in any online distribution system (including the users web page) at a resolution greater than 72dpi or 640x480 pixels.
- d. Provide a temporary copy to others of the Images and the Derivative Works, including any software (the product) which are an integral part of the users work product and reasonably required to produce a finished product in the normal course of the user's workflow.
- e. Make a single copy of the images for backup purposes.

### 2. Prohibited uses

The user is not permitted to:

- a. Do anything not expressly permitted under the paragraph headed "Permitted Uses"
- b. Post any Image on any electronic bulletin board
- c. Put the Images on-line in a downloadable format, or use the Images in a website at a resolution higher than 72dpi, or disassemble, decompile or "unlock", reverse engineer, translate or otherwise decode the product for any reason.
- d. Use any backup copy for any purpose other than to replace an original copy if it is destroyed or becomes defective.

- e. Use or permit the use of the images, or any part thereof, as a trademark or service mark or claim any proprietary rights of any sorts in the product, or any part thereof.
- f. Sell, sublicense, distribute or otherwise grant rights or make available for use by others all or a portion of the images in form or formats designed or intended for re-use of the images.
